## 3-5 Regulations Governing Vessel Garbage Removal At Mailiao Industrial Harbor Administration

- Article 1 These provisions are governed by Article 24 of the "Practices Governing the Planning and Construction of Industrial Harbors or Industrial Wharfs".
- Article 2 These provisions are formulated in accordance with the removal process of garbage generated from the kitchens and accommodations of the vessels berthing at Mailiao Industrial Harbor Administration (hereinafter referred to as the 'harbor').
- Article 3 Mailiao Industrial Harbor Administration Company (hereinafter referred to as the 'harbor company') or its agents shall be responsible for garbage removal from the vessels berthing at the harbor.
- Article 4 Garbage removal from the vessels berthing at the harbor starts from 13:00 to 15:00 pm every day.

## Article 5 Precautions for Garbage Removal:

- I. Garbage removal from the vessels berth at the harbor is conducted once a day. After the vessels berth at the wharf, the harbor agent shall pass the "Notification Form of Garbage Removal From the Vessels Berthing At Mailiao Industrial Harbor Administration" onto the shippers. If a vessel berths for more than 15 hours at the wharf and is estimated to depart from the port before 13:00 pm the next day, the shipper could apply for garbage removal from the vessel. After formally authorization, the harbor company shall aim to remove garbage from the vessel between 09:00 am and 12:00 pm the next day.
- II. Garbage removal contractors shall appoint garbage removal personnel and garbage removal trucks to the designated location to remove garbage from the vessel berthing at Mailiao Industrial Harbor Administration.

## Article 6 Rules that Shippers Must Follow During Garbage Removal

- I. In order to prevent garbage from being scattered around, the shipper shall first sort the garbage and then pack them up. Once the garbage removal personnel arrive on site, the shipper shall place the sorted garbage in the proper places.
- II. Garbage shall not be mixed with clearance cargo, dangerous goods, contraband, or untaxed non-trash items. Shippers shall be liable for any damages and losses incurred from any violations.
- III. Waste within the cabin not subject to the scope of garbage removal operations shall be cleaned up by the shipper voluntarily.

Article 7 Garbage removal personnel shall follow the relevant provisions of the Labor Safety and Health Act.

Article 8 After completing the garbage removal operation, the operator shall submit a "Vessel Garbage Removal Form" for the shipper to confirm and sign, with one copy kept by

the shipper, one copy kept by the harbor company, and one copy kept by the garbage removal contractor.

Article 9 These provisions shall come into effect after approval by the central competent authority and the same applies to any amendments made to these provisions.
